CALL FOR APPLICATIONS

During the academic year **2026-2027**, the Law School of National and Kapodistrian University of Athens will offer an intensive LL.M. Programme in International & European Law. Interested candidates are invited to submit their application as follows:

Description

The LL.M. Programme in International and European Law provides students with an indepth understanding of International and European Union Law in both their theoretical and practical aspects and leads to a postgraduate degree with a specialization in:

- a) **Public International Law**, or
- b) **European Union Law**

The course work is divided into two semesters (winter and spring), and students are obliged to submit a dissertation by 30 September 2027.

Eligibility requirements

To be eligible for admission, prospective students must:

- a) Hold a first Degree in Law from a Greek or Foreign Higher Educational Institute which belongs to Hellenic NARIC registers (https://www.doatap.gr/home_english/)

Non-Law degrees may be exceptionally accepted, if the Steering Committee is satisfied that they included coursework in relevant subjects. Students expected to graduate by the end of the current academic year 2025-2026 are also eligible to apply.

- b) Hold at least a C1 level certificate in English. Candidates with a degree entirely taught in English are exempted. Knowledge of additional languages is encouraged and taken into consideration.

Selection procedure

A maximum of twenty-five (25) students per specialization will be admitted. The Admissions Committee will assess the applications on the basis of each candidate's academic merits. Prospective students will be invited to an interview. Only candidates who meet the admission requirements will be invited to the interview.

Tuition fees

The annual tuition fee amounts to €4800.

Only for candidates who have completed their undergraduate studies at a non-Greek University:

Holders of academic degrees awarded by foreign Higher Education Institutions apply directly to the University and Programme they are interested in, according to its admission requirements. The University is responsible for the academic assessment of the degree/s and examines whether the institution that awarded the title belongs to the National Registry of Foreign Recognized Higher Education Institutes and whether the title type belongs to the National Registry of Foreign Recognized Academic Title Types (https://www.doatap.gr/home_english/)

A “**Certificate of Place of Study**” is mandatory only if the degree title has been awarded by an Institution included in the list of foreign Institutions awarding degrees through a franchise agreement with private entities in Greece. In this case, in addition to the other supporting documents specified, a “Certificate of Place of Study” (issued and sent by the foreign University) is also required. Be aware that when a foreign institution certifies as place of study (in whole or in part) facilities of a private institution in Greece, recognition of academic equivalence is not feasible.
